## **Introduction**

Met Éireann, Ireland's National Meteorological Service, is the leading provider of weather information and related services in the State. As detailed in its 2017-2027 Strategic Plan, Met Éireann's vision is to make Ireland Weather and Climate Prepared through helping Irish society to be ready for, and responsive to, weather-related challenges.

With its position relative to the North Atlantic storm track, Ireland is particularly exposed to the challenge of Atlantic storms, which can have considerable societal impacts. A small minority of these storms are tropical in origin, such as Storm Ophelia in 2017, and as such are distinct in terms of their development and underlying dynamics. Recent studies have suggested that the intensity and frequency of these storms may increase with climate change.

The aim of this research is to investigate how Ophelia-like storms may change in a warmer climate. The knowledge gained will help to inform climate mitigation and adaptation planning in relation to such storms. This will also serve to enhance support for impact-based decision making to improve societal preparedness in the face of high-impact, extreme weather.

### **1. Job Description:**

The goal of this project is to investigate the dynamics of post-tropical cyclones, such as Storms Ophelia and Lorenzo, and to quantify how these dynamics and the associated impacts on Ireland may change in a future warmer climate.

The Researcher will work in collaboration with Numerical Weather Prediction (NWP) and climate modelling colleagues, and use the operational HARMONIE-AROME model to carry out case studies of historical storms such as Ophelia and Lorenzo. An emerging framework for studying such extreme events and their changing impacts is the so-called "future weather" framework, whereby prescribed climatic forcings are used with high-resolution NWP models to stress-test meteorological events under physically-plausible scenarios. The Researcher will use this framework to study these storms in a warmer climate and to assess the changes in their associated impacts on Ireland.

The influence of Atlantic sea-surface temperatures (SSTs) on storm development is of particular interest, as well as the role of atmospheric humidity, air temperature and wind

shear. The Researcher will study the sensitivity of these storms to variations in these parameters. The role of diabatic heating processes in the initial intensification and post-tropical re-intensification is also of interest. The diabatic heating contributions from different model parameterizations will be calculated, combining with the sensitivity variations to form an ensemble of perturbations for each storm studied, starting with the present-day climate.

The climate forcings used will be derived from a range of CMIP6 SSP simulations recently completed by Met Éireann and ICHEC using the EC-Earth General Circulation Model. A cyclone identification and tracking algorithm will also be applied to downscaled CMIP6 EC-Earth data to identify future Ophelia-like tracks and to expand the number of storms studied. The resulting future-climate ensembles will be compared with the present-day ensemble to assess the potential effects of climate change. While the project will initially focus on meteorological extremes of wind-speed and precipitation, there are many possible extensions of this work and opportunities for internal collaboration across a range of areas.

## **2. Principal Tasks:**

- a) Use of the HARMONIE-AROME atmospheric model to reforecast historical storms
- b) Study the sensitivity of these storms to a changed background climate
- c) Compute the diabatic contributions from different model parameterizations, combining with the sensitivity variations to form an ensemble of perturbations for each storm, starting with the present day
- d) Use of EC-Earth climate projection data to inform climate scenarios
- e) Compute a future-climate ensemble and compare with present-day ensemble
- f) Collaboration with, and input to, other internal projects on impacts and NWP/climate modelling, time-permitting
- g) Publication of results in peer-reviewed scientific journals
- h) Communication of the research to both public and scientific audiences

## **Working Environment:**

A Postdoctoral Researcher will be required to work in Met Éireann Headquarters located at Glasnevin Hill, Dublin 9.

**Educational, professional or technical qualifications, knowledge, skills, aptitudes, experience, training:**

**a) ESSENTIAL for the job**

1. A Ph.D.\* or equivalent experience in atmospheric sciences, physics, mathematics or a related discipline is required.
2. Experience with numerical weather prediction or climate models
3. Knowledge of atmospheric or climate dynamics
4. Strong programming skills
5. Strong quantitative skills including data analysis
6. Effective oral and written communication skills

**a) DESIRABLE (but not essential) for the job**

1. A proven track record in peer-reviewed publications
2. Knowledge of storm dynamics and the effects of climate change

\*Applicants who expect to receive a Ph.D. in 2021 will also be considered.

## **ELIGIBILITY TO APPLY AND CERTAIN RESTRICTIONS ON ELIGIBILITY**

### **Eligibility to compete and certain restrictions on eligibility**

Candidates should note that eligibility to compete is only open to citizens of the European Economic Area (EEA). The EEA consists of the Member States of the European Union along with Iceland, Liechtenstein and Norway.

### **Incentivised Scheme for Early Retirement (ISER)**

It is a condition of the Incentivised Scheme for Early Retirement (ISER) as set out in Department of Finance Circular 12/09 that retirees, under that Scheme, are debarred from applying for another position in the same employment or the same sector. Therefore, such retirees may not apply for this position.

### **Department of Health and Children Circular (7/2010)**

The Department of Health Circular 7/2010 dated 1 November 2010 introduced a Targeted Voluntary Early Retirement (VER) Scheme and Voluntary Redundancy Schemes (VRS). It is a condition of the VER scheme that persons availing of the scheme will not be eligible for re-employment in the public health sector or in the wider public service or in a body wholly or mainly funded from public moneys. The same prohibition on re-employment applies under the VRS, except that the prohibition is for a period of 7 years, after which time any re-employment will require the approval of the Minister for Public Expenditure and Reform. People who availed of either of these schemes are not eligible to compete in this competition.

### **Collective Agreement: Redundancy Payments to Public Servants**

The Department of Public Expenditure and Reform letter dated 28<sup>th</sup> June 2012 to Personnel Officers introduced, with effect from 1<sup>st</sup> June 2012, a Collective Agreement which had been reached between the Department of Public Expenditure and Reform and the Public Services Committee of the ICTU in relation to ex-gratia Redundancy Payments to Public Servants. It is a condition of the Collective Agreement that persons availing of the agreement will not be eligible for re-employment in the public service by any public service body (as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011) for a period of 2 years from termination of the employment. Thereafter the consent of the Minister for Public Expenditure and Reform will be required prior to re-employment. People who availed of this scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility) and the Minister's consent will have to be secured prior to employment by any public service body.

### **Declaration**

Applicants will be required to declare whether they have previously availed of a public service scheme of incentivised early retirement and/or the collective agreement outlined above. Applicants will also be required to declare any entitlements to a Public Service pension benefit (in payment or preserved) from any other Public Service employment and/or where they have received a payment-in-lieu in respect of service in any Public Service employment.

## Principal Conditions of Service

### **General:**

The appointment is subject to the Civil Service Regulations Acts 1956 to 2005 and the Public Service Management (Recruitment and Appointments) Act 2004 and any other Act for the time being in force relating to the Civil Service.

**Pay:** On appointment €45,853 per annum, after 1 year €47,546 year per annum

### **Important Note**

Payment will be made fortnightly in arrears by Electronic Fund Transfer (EFT) into a bank account of an officer's choice. Payment cannot be made until a BIC code and IBAN number and bank sort code has been supplied to the Personnel Section of the relevant Department or Office. Statutory deductions from salary will be made as appropriate by the Department/Office.

An officer will agree that any overpayment of salary or of travel and subsistence may be deducted from future salary payments due to an officer in accordance with the Payment of Wages Act 1991. In accordance with that Act, the Department/Office will advise the officer in writing of the amount and details of such overpayment and give at least one week's notice of the deduction to take place and will deduct the overpayment, at an amount that is fair and reasonable having regard to all the circumstances, within six months of such notice in accordance with the Act.

### **Tenure and probation:**

The appointment is to a **temporary** unestablished position in the civil service for a period of 2 years.

The appointee will be required to serve a 6-month probationary period.

During the period of the probationary contract, an officer's performance will be subject to review by the appropriate supervisor(s) to determine whether the officer:

- I. has performed in a satisfactory manner
- II. has been satisfactory in general conduct, and
- III. is suitable from the viewpoint of health with particular regard to sick leave.

Prior to completion of the probationary contract a decision will be made as to whether or not the officer will be retained pursuant to *Section 5A(2) Civil Service Regulation Acts 1956-2005*. This decision will be based on the officer's performance assessed against the criteria set out in (i) to (iii) above. The detail of the probationary process will be explained to the officer by the Department/Office. A copy of Department of Finance guidelines on probation will also be made available to the officer.

Where an officer is an existing civil servant and is not considered as suitable to the position having been assessed against stated criteria, the officer will be notified in writing of the action to be taken prior to the expiry of the probationary contract and any extensions thereof.

Notwithstanding the preceding paragraphs in this section, the probationary contract may be terminated at any time prior to the expiry of the term of the contract by either side in accordance with the Minimum Notice and Terms of Employment Acts, 1973 to 2005.

In certain circumstances the contract may be extended and the probation period suspended. The extension must be agreed by both parties.

- The probationary period stands suspended where an employee is absent due to Maternity or Adoptive Leave
- In relation to an employee absent on Parental Leave or Carers Leave, the employer may require probation to be suspended if the absence is not considered to be consistent with a continuation of the probation
- Probation may be suspended in cases such as absence due to a non-recurring illness.

The employee may in these circumstances make application to the employer for an extension to the contract period.

#### **Unfair Dismissals Act 1977 - 2005:**

The Unfair Dismissals Acts 1977-2005 will not apply to the termination of this employment by reason only of the expiry of this probationary contract without it being renewed.

#### **Duties:**

The officer will be required to perform any duties appropriate to the position which may be assigned from time to time. The position is full time and the officer may not engage in private practice or be connected with any outside business which would interfere with the performance of official duties.

#### **Headquarters:**

The officer's headquarters will be such as may be designated from time to time by the Director. When absent from home and headquarters on duty appropriate travelling expenses and subsistence allowances will be paid, subject to the normal civil service regulations and the guidelines of Department of Housing, Local Government and Heritage.

#### **Hours of attendance:**

Hours of attendance will be as fixed from time to time but will amount, on average, to not less than 43 hours and 15 minutes gross or 37 hours net of lunch breaks. Flexibility may be required with regard to extra attendance from time to time. The rate of remuneration payable for any exceptional extra attendance will be in line with Department of Public Expenditure and Reform circulars.

#### **Annual Leave**

On recruitment, annual leave will be 25 working days a year. This allowance, which is subject to the usual conditions regarding the granting of annual leave, is on the basis of a five-day week and is exclusive of the usual public holidays

**The Organisation of Working Time Act:**

The terms of the organisation of Working Time Act, 1997 will apply, where appropriate, to this employment.

**Sick Leave:**

Pay during properly certified sick absence, provided there is no evidence of permanent disability for service, will apply on a pro-rata basis, in accordance with the provisions of the sick leave circulars as amended from time to time.

Officers, who will be paying the Class A rate of PRSI, will be required to sign a mandate authorising the Department of Social Protection to pay any benefits due under the Social Welfare Acts direct to the Department of Environment, Community and Local Government. Payment of salary during illness will be subject to the officer making the necessary claims for social insurance benefit to the Department of Social Protection within the required time limits.

**Secrecy, confidentiality and standards of behaviours:**

**Official Secrecy and Integrity**

During the term of the probationary contract, an officer will be subject to the Provisions of the Official Secrets Act, 1963, as amended by the Freedom of Information Acts 1997 and 2003. The officer will agree not to disclose to third parties any confidential information, especially information with commercial potential, either during or subsequent to the period of employment.

**Civil Service Code of Standards and Behaviour**

The officer will be subject to the Civil Service Code of Standards and Behaviour.

**Ethics in Public Office Act 1995**

The Ethics in Public Office Acts 1995 will apply, where appropriate, to this employment.

**Prior approval of publications:**

An officer will agree not to publish material related to his or her official duties without prior approval by the Secretary General of the Department.

**Political activity:**

During the term of employment the officer will be subject to the rules governing civil servants and politics.

**Superannuation and Retirement**

The successful candidate will be offered the appropriate superannuation terms and conditions as prevailing in the Civil Service, at the time of being offered an appointment. In general, and except for candidates who have worked in a pensionable (non-single scheme terms) public service job in the 26 weeks prior to appointment (see paragraph d below), this means being offered appointment based on membership of the Single Public Service Pension Scheme ("Single Scheme"). Key provisions attaching to membership of the Single Scheme are as follows:

**a. Pensionable Age**

The minimum age at which pension is payable is 66 (rising to 67 and 68) in line with State Pension age changes.

**b. Retirement Age:**

Scheme members must retire at the age of 70.

**c. Pension Abatement**

- If the appointee was previously employed in the Civil Service and is in receipt of a pension from the Civil Service normal abatement rules will apply. However, if the appointee was previously employed in the Civil Service and awarded a pension under voluntary early retirement arrangements (other than the Incentivised Scheme of Early Retirement (ISER) or the Department of Health Circular 7/2010 VER/VRS which, as indicated above, renders a person ineligible for the competition) the entitlement to that pension will cease with effect from the date of reappointment. Special arrangements will, however be made for the reckoning of previous service given by the appointee for the purpose of any future superannuation award for which the appointee may be eligible.
- If the appointee was previously employed in the Civil Service or in the Public Service please note that the Public Service Pensions (Single Scheme and Other Provisions) Act 2012 includes a provision which extends abatement of pension for all Civil and Public Servants who are re-employed where a Public Service pension is in payment. This provision to apply abatement across the wider public service came into effect on 1 November 2012. **This may have pension implications for any person appointed to this position who is currently in receipt of a Civil or Public Service pension or has a preserved Civil or Public Service pension which will come into payment during his/her employment in this position.**
- **Department of Education and Skills Early Retirement Scheme for Teachers Circular 102/2007**

The Department of Education and Skills introduced an Early Retirement Scheme for Teachers. It is a condition of the Early Retirement Scheme that with the exception of the situations set out in paragraphs 10.2 and 10.3 of the relevant circular documentation, and with those exceptions only, if a teacher accepts early retirement under **Strands 1, 2 or 3** of this scheme and is subsequently employed in any capacity in any area of the public sector, payment of pension to that person under the scheme **will immediately cease**. Pension payments will, however, be resumed on the ceasing of such employment or on the person's 60<sup>th</sup> birthday, whichever is the later, but on resumption, the pension will be based on the person's actual reckonable service as a teacher (i.e. the added years previously granted will not be taken into account in the calculation of the pension payment).

- **Ill-Health-Retirement**

Please note that where an individual has retired from a Civil/Public Service body on the grounds of ill-health his/her pension from that employment may be subject to review in accordance with the rules of ill-health retirement within the pension scheme of that employment.

**d. Prior Public Servants**

While the default pension terms, as set out in the preceding paragraphs, consist of Single Scheme membership, this may not apply to certain appointees. Full details of the conditions governing whether or not a public servant is a Single Scheme member are given in the

Public Service Pensions (Single Scheme and other Provisions) Act 2012. However, the key exception case (in the context of this competition and generally) is that **a successful candidate who has worked in a pensionable (non-single scheme terms) capacity in the public service within 26 weeks of taking up appointment, would in general not become a member of the Single Scheme.** In this case such a candidate would instead be offered membership of the pension scheme for non-established civil servants ("Non-Established State Employee Scheme"). This would mean that the abatement provisions at (c) above would apply, and in addition there are implications in respect of pension accrual as outlined below:

**e. Pension Accrual**

A 40-year limit on total service that can be counted towards pension where a person has been a member of more than one existing public service pension scheme would apply. This 40-year limit, which is provided for in the Public Service Pensions (Single Scheme and other Provisions) Act 2012 came into effect on 28 July 2012. **This may have implications for any appointee who has acquired pension rights in a previous public service employment.**

**f. Pension-Related Deduction**

This appointment is subject to the pension-related deduction in accordance with the Financial Emergency Measure in the Public Interest Act 2009.
