Met Éireann

Met Éireann, Ireland's National Meteorological Service, is tasked with the provision of a wide range of services related to weather, climate, and flooding to help protect life and property and promote societal and economic wellbeing. It provides services to a broad range of sectors including air and land transport, marine and agriculture. It also plays a key role in the State's emergency planning and management functions through its production and communication of warnings related to weather hazards.

Met Éireann's mission as highlighted in our Strategic Plan 2024 - 2034 *"Ready for change - preparing Ireland for changing weather and climate"* is to provide Irish society and decision-makers with world-class weather, climate, and flood services to protect life and property, and to promote wider societal and economic well-being.

Met Éireann has a current staffing level more than 250 employees across nine divisions. The majority of staff are based at Met Éireann's headquarters at Glasnevin, Dublin close to the National Botanic Gardens, and a number of staff are based at airport locations across the country and at Met Éireann's Valentia Observatory in Cahersiveen, Co. Kerry.

Meteorologist/Hydrometeorologist/Research and Development Meteorologist Vacancies

Met Éireann is currently recruiting for the positions of

- 1. Weather Forecaster (Meteorologist)
- 2. Flood Forecaster (Hydrometeorologist)
- 3. Research and Development Meteorologist

Weather and Flood Forecasters, in Met Éireann, produce and communicate weather, flood and impact-based services and warnings on an operational basis. Forecasters analyse observations and model predictions, develop products and messages for the general public and specific sectors. Met Éireann is also recruiting Research and Development Meteorologists to work across a wide range of functional areas, engaging in research projects and scientific and infrastructural developments and providing critical services to stakeholder in Ireland and internationally. These are exciting roles and successful candidates will work in a dynamic and engaging work environment, centred around ongoing, rapid advances in science, technology and communications. There are multiple vacancies to be filled across all positions.



Brief description of the roles

Weather and Flood Forecasters work as members of operational teams delivering services across day, evening and night duties, through the week and weekends. The work entails detailed and on-going analysis of current conditions; the use of forecast models and other tools to determine the likely evolution of physical systems over the short and medium term; the translation of that knowledge into forecasts and warnings, and the communication of forecasts and warnings through a wide variety of media. Forecasters can be assigned to general forecasting duties, or to providing specialised forecast and warnings services for aviation or flood forecasting. Depending on the shift pattern, these positions potentially attract up to 27% shift allowance, three additional days of annual leave, as well as extra payments for public holidays.

Research and Development Meteorologists work traditional office hours across the organisation, with responsibilities and duties varying, depending on the assignment. Such areas of work include increasing resolution and related data volumes in weather and climate models; engaging with international partners to improve the performance and future scalability of our forecasting model codes; utilising Machine Learning (ML) and Artificial Intelligence (AI) methods to apply promising algorithms in the operational environment; analysis of the climate of the past and present and future climate projections; development of weather, climate and environmental monitoring programs as well as robust data management systems to reliably provide the accurate observational data which underpin all of Met Éireann's operations.

Principal duties and role criteria

Weather Forecaster

Weather Forecasters at Meteorologist grade will be required to carry out some or all of the following duties:

- Production of forecasts and related information for the general public, the media, Defence Forces, Government Departments, public utilities and various sectors of the economy, such as the aviation, transport and energy sectors, agriculture and industry;
- Communication of weather, climate and impact-based services across a range of media including digital, radio and TV. Participation in outreach and public engagement activities;



- Engagement with weather, climate and impact services users and designing and implementing service improvements and developments;
- Briefing Government Agencies, Emergency Responders during times of extreme weather in National Emergency Co-ordination Group meetings;
- Engage with their colleagues in the provision of weather briefings as well as the drafting of weather warnings;
- Analysing and monitoring the evolving meteorological situation as it relates to Ireland and Irish aviation services;
- Interpreting observational and numerical model data to forecast meteorological and hydrological phenomena and parameters;
- Effectively communicating meteorological information, together with associated uncertainties where appropriate, to internal and external users;
- Advising customers on the interpretation of forecast data and the likely impacts on their activities;
- Delivering live radio broadcasts, and possibly television presentations;
- Facilitating media enquiries and interviews;
- Developing forecast products and warnings of high-impact phenomena;
- Ensuring the quality of weather processes, systems and services.

The Weather Forecaster will be required to perform any other duties which may be assigned from time to time, as appropriate to the position.

Essential for the role

In addition to the criteria listed below, candidates applying for both positions must be able to demonstrate the key competencies, set out on page 26.

Each candidate must have, on or before the closing date, a minimum of Level 8 on the National Framework of Qualifications in one or more of the following (or a recognised equivalent)

- Physics
- Mathematics
- Mathematical Physics
- Meteorology
- Earth and Environmental Sciences or some sub-discipline thereof, including oceanography, atmospheric science, climatology or hydrology

Candidates must also possess:



- The ability to speak and write fluently in English
- Excellent communications skills
- Proven ability to analyse and problem solve
- Strong decision-making skills
- Excellent interpersonal skills and ability to work as part of a team
- Knowledge of meteorological or Earth sciences and its applications or demonstrable ability to acquire such knowledge
- Good IT Skills

Desirable for the role

It would be highly desirable, but not essential, if candidates possess the following:

- Experience as a Weather Forecaster or in the development or delivery of impactbased weather services
- Experience in digital or traditional media communications
- Experience in customer service delivery
- Experience in Meteorology, Climatology, Hydrology, Oceanography or related other Earth Science related discipline

Flood Forecaster

Flood Forecasters at Hydrometeorologist grade will be required to carry out some or all of the following duties:

- Production of flood forecasts, guidance statements, alerts and advisories and related information to support emergency management decision-making;
- Ongoing development and delivery of Met Éireann's flood forecasting services;
- Monitor, assess and analysis water levels, coastal levels, hydrological and meteorological conditions, and hydrological and coastal model outputs to the production of flood forecasts;
- Identification of severe weather events and hydrological conditions when the risk of flooding is expected to increase;
- Development of operational products to support the Flood Forecast Centre;
- Maintaining and developing Met Éireann's operational flood modelling systems at national, catchment, sub-catchment and local levels and coastal tide, surge and wave models;
- Undertaking research and leading developments on aspects of hydrological and coastal modelling;



- Development of hydrological and/or coastal models and techniques to improve the quality of products and services provided;
- Management of hydrological, oceanography, hydrometric data sets to be used in the Flood Forecast Centre;
- Identification and development of observational networks to support flood forecasting;
- Working as part of a shift team maintaining a 365-day service including working duties at weekends and public holidays;
- Working with national and international organisations such as the Office of Public Works, NOOS, EuroGOOS and the European Flood Awareness System (EFAS) to realise the operational benefits of model improvements;
- Liaising with Meteorological forecast colleagues with the aim of increasing their knowledge and awareness of hydrological processes and flood risks;
- Participate in seminars with business partners in the area of operational flood forecasting;
- Effectively communicating hydrometeorological information, together with associated uncertainties where appropriate, to internal and external users;
- Briefing Government Agencies, Emergency Responders during times of flooding events associated with extreme weather related in National Emergency Co-ordination Group meetings;
- Represent Met Éireann's Flood Forecast Centre at national and international meetings and conferences etc;
- Procurement of IT systems and instrumentation to support the Flood Forecast Centre.
- Development and management of the Irish Flood Integrated Communication System
- Ensuring the quality of flood forecasting processes, systems and services.

The Flood Forecaster will be required to perform any other duties which may be assigned from time to time, as appropriate to the position.

Essential for the role

Each candidate must have, on or before the closing date, a minimum of Level 8 on the National Framework of Qualifications in one or more of the following (or a recognised equivalent)

- Hydrology
- Oceanography
- Meteorology



- Environmental Sciences
- Physics
- Mathematics
- Civil Engineering
- A discipline with Hydrology, Coastal Engineering, Water Resources Engineering, Hydraulic Engineering or Hydrogeology as a major component (e.g. Civil Engineering, Earth and Environmental Sciences, Geography, Geology)

Candidates must also possess:

- The ability to speak and write fluently in English
- Excellent communications skills
- Proven ability to analyse and problem solve
- Strong decision-making skills
- Excellent interpersonal skills and ability to work as part of a team
- Knowledge of hydrometeorology and its applications or demonstrable ability to acquire such knowledge
- Good IT Skills

In addition to the criteria listed above, candidates applying must be able to demonstrate the key competencies, set out on page 26.

Desirable for the role

It would be highly desirable, but not essential, if candidates possess the following:

- PhD in the development or application of computational modelling in areas relating to the water environment (e.g. Hydrometeorology, Hydrology, Hydrogeology, Coastal modelling, Hydraulic engineering, Urban drainage, etc.)
- Previous experience of working in a flood forecasting environment
- Previous experience of developing coastal flood forecasting models
- Completed core hydrology, hydrogeology, coastal engineering, water engineering or meteorology training competencies
- Experience of working as part of a shift team maintaining an operational service
- GIS experience e.g. ArcGIS, QGIS, PostGIS
- Ability and experience in programming such as with python and R and Linux/Unix environments
- Experience in high performance computing in a Linux/Unix environment
- Experience of Machine Learning or AI in a flood forecasting environment



Research & Development Meteorologist

Research & Development Meteorologists will be required to carry out some or all of the following duties:

- Operations and maintenance of weather forecast models and the timely delivery of forecast data to end-users;
- Production of data products and statistical information and provision of technical advice on the applications of meteorology and climatology to stakeholders;
- Research and development of numerical weather prediction models and techniques to improve the quality of products and services provided;
- Climate change studies, including climate modelling and analyses;
- Development of Climate Services and the analysis of past and future climate data;
- Conducting research into climate variability, trends and extremes using statistical and mathematical models;
- Maintain and enhance operational climate services;
- Research and development of meteorological, climatological, agricultural and environmental applications in co-operation, where appropriate, with other domestic and international agencies;
- Communication of weather and climate science across a range of media including digital, radio and TV;
- Participation in outreach and public engagement activities;
- Engagement with weather, climate & hydrological users and developing service improvements;
- Development and implementation of artificial intelligence and machine learning (AI/ML) techniques in weather and climate prediction systems and end-user applications in collaboration with national and international organisations;
- Participation in various international research consortia and projects.

In addition to the criteria listed above, candidates applying must be able to demonstrate the key competencies, set out on page 26.

Essential for the role

Candidates must have on or before the closing date, a minimum of Level 8 on the National Framework of Qualifications in one or more of the following (or a recognised equivalent)

• Physics



- Mathematics
- Mathematical Physics
- Meteorology
- Climatology
- Earth and Environmental Sciences or some sub-discipline thereof, including oceanography, atmospheric science, climatology, or hydrology
- Computational Science with specialisation in AI/ML
- Engineering with a strong mathematical and/or computational component

Candidates must also possess:

- The ability to speak and write fluently in English
- Excellent communications skills
- Proven ability to analyse and problem solve
- Strong decision-making skills
- Excellent interpersonal skills and ability to work as part of a team
- Knowledge of meteorological, climatology or Earth sciences and its applications or demonstrable ability to acquire such knowledge
- Good IT Skills

Desirable for the role

It would be highly desirable, but not essential, if candidates possess the following:

- Experience in meteorology, climatology, or oceanography
- Experience in scientific programming with R or Python
- Experience in high-performance computing in a Linux/Unix environment
- Experience in Artificial Intelligence/Machine learning techniques
- Ph.D. in any of the following areas: Atmospheric Physics, Oceanography, Meteorology, Data Science, Computational Science, Computational Fluid Dynamics or similar

Working Environment

Weather and Flood Forecasters work in an operational environment and are required to work shift duties. This may, depending on role assigned, involve a mix of day, evening and night duties and includes work at weekends and on public holidays.

Forecasters have some blended working/work from home opportunities, subject to the business requirements of their operational functions.



Weather forecasters will receive, where applicable, a shift premium up to 27% as well as additional holidays for working on a 24/7 shift roster including night shifts.

Flood Forecasters will receive, where applicable, a shift premium up to 20% as well as additional holidays for working on a 7-day shift roster.

Research and Development Meteorologists work traditional office hours and, subject to terms, conditions and suitability of work, may be approved to avail of blended working.

Working in constantly changing scientific and technical environments, Forecasters and Research and Development Meteorologists must be able and willing to adapt to new methods and procedures and to the use of new equipment and techniques. Officers may be required to work in any part of the State or occasionally attend international meetings or study courses, or work for limited periods with international organisations or with other meteorological/hydrological services.

Location

All recruits in this competition will be based initially at Met Éireann HQ, Glasnevin Hill, Dublin 9. It should be noted that all recruits at this grade may be required to take on new tasks or be assigned to different functional areas, work patterns or locations in response to changing business needs. Where possible, the successful candidates may be authorised to work remotely in line with approved policies for blended working.

Training

Met Éireann is committed to providing all employees with access to structured Continuous Professional Development. Where appropriate new Meteorologists may be provided with training designed to bring the officer to the required proficiency level.

Newly appointed Weather Forecasters and Flood Forecasters will be required to engage in up to one year of training in meteorology, or climatology, with a chosen National Met Service outside Ireland, in line with World Meteorological Organization standards.

Weather Forecasters / Flood Forecasters who are deemed by Met Éireann to already possess the necessary qualifications at the time of their appointment will not be required to complete this training. This requirement does not apply to Research and Development Meteorologists



Eligibility to compete and certain restrictions on eligibility

Citizenship Requirements

Eligible candidates must be:

- (a) A citizen of the European Economic Area (EEA). The EEA consists of the Member States of the European Union, Iceland, Liechtenstein and Norway; or
- (b) A citizen of the United Kingdom (UK); or
- (c) A citizen of Switzerland pursuant to the agreement between the EU and Switzerland on the free movement of persons; or
- (d) A non-EEA citizen who has a stamp 4¹ or a Stamp 5 permission;

To qualify candidates must meet one of the citizenship criteria above by the date of any job offer.

Collective Agreement: Redundancy Payments to Public Servants

The Department of Public Expenditure and Reform letter dated 28th June 2012 to Personnel Officers introduced, with effect from 1st June 2012, a Collective Agreement which had been reached between the Department of Public Expenditure and Reform and the Public Services Committee of the ICTU in relation to ex-gratia Redundancy Payments to Public Servants. It is a condition of the Collective Agreement that persons availing of the agreement will not be eligible for re-employment in the Public Service by any Public Service body (as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011) for a period of 2 years from termination of the employment. People who availed of this scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility).

Incentivised Scheme for Early Retirement (ISER)

It is a condition of the Incentivised Scheme for Early Retirement (ISER) as set out in Department of Finance Circular 12/09 that retirees, under that Scheme, are not eligible to apply for another position in the same employment or the same sector. Therefore, such retirees may not apply for this position.

Department of Health and Children Circular (7/2010)

¹ Please note that a 50 TEU visa, which is a replacement for Stamp 4EUFAM after Brexit, is acceptable as a Stamp 4 equivalent



The Department of Health Circular 7/2010 dated 1 November 2010 introduced a Targeted Voluntary Early Retirement (VER) Scheme and Voluntary Redundancy Schemes (VRS). It is a condition of the VER scheme that persons availing of the scheme will not be eligible for reemployment in the public health sector or in the wider Public Service or in a body wholly or mainly funded from public moneys. The same prohibition on re-employment applies under the VRS, except that the prohibition is for a period of 7 years. People who availed of the VER scheme are not eligible to compete in this competition. People who availed of the VRS scheme and who may be successful in this competition will have to prove their eligibility (expiry of period of non-eligibility).

Department of Environment, Community & Local Government (Circular Letter LG(P) 06/2013)

The Department of Environment, Community & Local Government Circular Letter LG(P) 06/2013 introduced a Voluntary Redundancy Scheme for Local Authorities. In accordance with the terms of the *Collective Agreement: Redundancy Payments to Public Servants* dated 28 June 2012 as detailed above, it is a specific condition of that VER Scheme that persons will not be eligible for re-employment in any Public Service body [as defined by the Financial Emergency Measures in the Public Interest Acts 2009 – 2011 and the Public Service Pensions (Single Scheme and Other Provisions) Act 2012] for a period of 2 years from their date of departure under this Scheme. These conditions also apply in the case of engagement/employment on a contract for service basis (either as a contractor or as an employee of a contractor).

Declaration

Applicants will be required to declare whether they have previously availed of a Public Service scheme of incentivised early retirement. Applicants will also be required to declare any entitlements to a Public Service pension benefit (in payment or preserved) from any other Public Service employment and/or where they have received a payment-in-lieu in respect of service in any Public Service employment.

Employer of Choice

As an Employer of Choice the Civil Service has many flexible and family friendly policies e.g. Work-sharing, Shorter Working Year, Remote Working (operated on a 'blended' basis) etc. All elective policies can be applied for in accordance with the relevant statutory provisions and are subject to the business needs of the organisation.

The Civil Service also operates a Mobility scheme for all general service grades. This scheme provides staff with career opportunities to learn and partake in diverse roles across a range



of Civil Service organisations and geographical locations.

Principal Conditions of Service

<u>General</u>

The appointment is subject to the Civil Service Regulations Acts 1956 to 2005 and the Public Service Management (Recruitment and Appointments) Act 2004 and any other Act for the time being in force relating to the Civil Service.

<u>Pay</u>

Personal Pension Contribution (PPC) Pay Scale:

The salary scale for the position (rates effective from 01 March 2025) is as follows:

Weather Forecasters, assigned to a 24/7 shift pattern, will have a shift allowance of up to 27% applied to their salary, plus an additional 3 days' annual leave per annum.

Flood Forecasters, assigned to a 7 day shift pattern, will have a shift allowance of up to 20% applied to their salary, plus an additional 2 days' annual leave per annum.

The PPC pay rate applies when the individual is required to pay a <u>Personal Pension</u> <u>Contribution (otherwise known as a main scheme contribution) in accordance with the rules</u> of their main/personal superannuation scheme. This is different to a contribution in respect of membership of a Spouses' and Children's scheme, or the Additional Superannuation Contributions (ASC).

A different rate will apply where the appointee is not required to make a Personal Pension Contribution.

Salary increments are awarded annually following successful competition of the officer's ePMDS process (Performance Management & Development System). PMDS is a civil service



wide system which supports all employees and managers in managing and improving individual performance.

Long Service Increments may be payable after 3 years (LSI1) and 6 years (LSI2) satisfactory service at the maximum of the scale.

Important Note

Entry will be at the minimum of the scale and the rate of remuneration will not be subject to negotiation and may be adjusted from time to time in line with Government pay policy.

Different terms and conditions may apply if you are a currently serving civil or public servant.

Subject to satisfactory performance increments may be payable in line will current Government Policy.

Different terms and conditions may apply if, immediately prior to appointment, the appointee is a serving civil or public servant.

Payment will be made fortnightly in arrears by Electronic Fund Transfer (EFT) into a bank account of an officer's choice. Payment cannot be made until a BIC code and IBAN number and bank sort code has been supplied to the Personnel Section of the relevant Department or Office. Statutory deductions from salary will be made as appropriate by the Department/Office.

The appointee will agree that any overpayment of salary, allowances, or expenses will be repaid by you in accordance with Circular 07/2018: Recovery of Salary, Allowances, and Expenses Overpayments made to Staff Members/Former Staff Members/Pensioners.

Tenure and Probation

The appointment is to a permanent position in the Civil Service where the appointee will be required to serve a 12 month probationary period. During the period of the probationary contract, an officer's performance will be subject to review by the appropriate supervisor(s) to determine whether the officer:

- I. has performed in a satisfactory manner
- II. has been satisfactory in general conduct, and
- III. is suitable from the viewpoint of health with particular regard to sick leave.



Prior to completion of the probationary contract a decision will be made as to whether or not the officer will be retained pursuant to Section 5A(2) Civil Service Regulation Acts 1956-2005. This decision will be based on the officer's performance assessed against the criteria set out in (i) to (iii) above.

The details of the probationary process will be explained to you by your employing Department and you will be given a copy of guidelines on probation issued by the Department of Public Expenditure and Reform.

In the event that an officer is not considered as suitable to the position having been assessed against stated criteria, the officer will be notified in writing of the action to be taken prior to the expiry of the probationary contract and any extensions thereof.

Notwithstanding the preceding paragraphs in this section, the probationary contract may be terminated at any time prior to the expiry of the term of the contract by either side in accordance with the Minimum Notice and Terms of Employment Acts, 1973 to 2005.

In the following circumstances a contract may be extended and a probation period suspended.

- The probationary period stands suspended when an employee is absent due to Maternity or Adoptive Leave.
- In relation to an employee absent on Parental Leave or Carers Leave, the employer may require probation to be suspended if the absence is not considered to be consistent with the continuation of the probation and
- Any other statutory provision providing that probation shall -
 - (i) stand suspended during an employee's absence from work, and
 - (ii) be completed by the employee on the employees return from work after such absence.

Where probation is suspended the employer should notify the employee of the circumstances relating to the suspension.

All appointees will serve a one-year probationary period. If an appointee who fails to satisfy the conditions of probation has been a serving civil servant immediately prior to their appointment from this competition, the issue of reversion will normally arise. In the event of reversion, an officer will return to a vacancy in their former grade in their former Department.



Outside Employment

The position will be whole time, and the appointee may not engage in private practice or be connected with any outside business, which conflicts in any way with his/her official duties, impairs performance or comprises his/her integrity.

Headquarters

The person appointed will be located in Met Éireann's Headquarters in Glasnevin, Dublin. Where possible, the successful candidates may be authorised to work remotely in line with approved policies for blended working.

Work outside of normal hours may on occasion be necessary as workloads dictate. This may include weekdays and/or weekends and may occasionally require travel both nationally and internationally.

<u>Unfair Dismissals Act 1977 – 2015</u>

The Unfair Dismissals Acts 1977-2015 will not apply to the termination of this employment by reason only of the expiry of this probationary contract without it being renewed.

Annual Leave

Annual leave will be 25 days, rising to 29 days after 5 years' service and to 30 on reaching point 9 or after a further 3 years. This allowance, which is subject to the usual conditions regarding the granting of annual leave, is on the basis of a five-day week and is exclusive of the usual public holidays. Weather Forecasters, who are assigned to 24/7 shift duties will receive an additional 3 days' annual leave. Flood Forecasters, who are assigned to a 7 day shift pattern will receive an additional 2 days' annual leave.

Duties

The officer will be required to perform any duties appropriate to the position which may be assigned from time to time. The position is full time and the officer may not engage in private practice or be connected with any outside business which would interfere with the performance of official duties.

Hours of Attendance

Hours of attendance are as fixed from time to time. The current requirement is 41 hours and 15 minutes gross or 35 hours **net of lunch breaks** per week. Shift pay at the rate of 27% of basic salary is payable to officers on 24-hour rostered duties and at the rate of 20% for those operating 7 day rosters. Special arrangements also apply for attendance on public holidays and for extra attendances.



Organisation of Working Time Act 1997

The terms of the Organisation of Working Time Act 1997 will, where appropriate, apply to this appointment.

Sick Leave

Pay during properly certified sick absence, provided there is no evidence of permanent disability for service, will apply on a pro-rata basis, in accordance with the provisions of the sick leave circulars for the public service.

Officers, who will be paying the Class A rate of PRSI, will be required to sign a mandate authorising the Department of Social Protection to pay any benefits due under the Social Welfare Acts direct to the Department of Housing, Local Government and Heritage. Payment of salary during illness will be subject to the officer making the necessary claims for social insurance benefit to the Department of Social Protection within the required time limits.

Official Secrecy and Integrity

During the term of the probationary contract, an officer will be subject to the Provisions of the Official Secrets Act, 1963, as amended by the Freedom of Information Act 2014. The officer will agree not to disclose to unauthorised third parties any confidential information, especially information with commercial potential, either during or subsequent to the period of employment.

Civil Service Code of Standards and Behaviour

The officer will be subject to the Civil Service Code of Standards and Behaviour.

Ethics in Public Office Act 1995 to 2001

The Ethics in Public Office Acts 1995 to 2001 will apply, where appropriate, to this employment.

Political activity

During the term of employment the officer will be subject to the rules governing civil servants and politics.

Prior approval of publications

An officer will agree not to publish material related to their official duties without prior approval by the Head of the Employing Department/ Organisation or by another appropriate authorised officer.

Superannuation and Retirement

The successful candidate will be offered the appropriate superannuation terms and conditions as prevailing in the Civil Service at the time of being offered an appointment. In general, an appointee who has never worked in the Public Service will be offered appointment based on membership of the Single Public Service Pension Scheme ("Single Scheme"). Full details of the Scheme are at <u>www.singlepensionscheme.gov.ie</u>.

Where the appointee has worked in a pensionable (non-Single Scheme terms) public service job in the 26 weeks prior to appointment or is currently on a career break or special leave with/without pay different terms may apply. The pension entitlement of such appointees will be established in the context of their public service employment history.

Key provisions attaching to membership of the Single Scheme are as follows:

- Pensionable Age The minimum age at which pension is payable is the same as the age of eligibility for the State Pension, currently 66.
- Retirement Age: Scheme members must retire at the age of 70.
- Career average earnings are used to calculate benefits (a pension and lump sum amount accrue each year and are up-rated each year by reference to CPI).
- Post retirement pension increases are linked to CPI.

Pension Abatement

If the appointee has previously been employed in the Civil or Public Service and is in receipt of a pension from the Civil or Public Service or where a Civil/Public Service pension comes into payment during his/her re-employment that pension **will be subject to abatement** in accordance with Section 52 of the Public Service Pensions (Single Scheme and Other Provisions) Act 2012. **Please Note: In applying for this position you are acknowledging that you understand that the abatement provisions, where relevant, will apply. It is not envisaged that the employing Department/Office will support an application for an abatement waiver in respect of appointments to this position**.



However, if the appointee was previously employed in the Civil or Public Service and awarded a pension under voluntary early retirement arrangements (other than the Incentivised Scheme of Early Retirement (ISER), the Department of Health Circular 7/2010 VER/VRS or the Department of Environment, Community & Local Government Circular letter LG(P) 06/2013, any of which renders a person ineligible for the competition)the entitlement to that pension will cease with effect from the date of reappointment. Special arrangements may, however be made for the reckoning of previous service given by the appointee for the purpose of any future superannuation award for which the appointee may be eligible.

Department of Education and Skills Early Retirement Scheme for Teachers Circular 102/2007

The Department of Education and Skills introduced an Early Retirement Scheme for Teachers. It is a condition of the Early Retirement Scheme that with the exception of the situations set out in paragraphs 10.2 and 10.3 of the relevant circular documentation, and with those exceptions only, if a teacher accepts early retirement under Strands 1, 2 or 3 of this scheme and is subsequently employed in any capacity in any area of the public sector, payment of pension to that person under the scheme will immediately cease. Pension payments will, however, be resumed on the ceasing of such employment or on the person's 60th birthday, whichever is the later, but on resumption, the pension will be based on the person's actual reckonable service as a teacher (i.e. the added years previously granted will not be taken into account in the calculation of the pension payment).

Ill-Health-Retirement

Please note any person who previously retired on ill health grounds under the terms of a superannuation scheme are required to declare, at the initial application phase, that they are in receipt of such a pension to the organisation administering the recruitment competition.

Applicants will be required to attend the CMO's office to assess their ability to provide regular and effective service taking account of the condition which qualified them for IHR.

Appointment post ill-health retirement from Civil Service

If successful in their application through the competition, the applicant should be aware of the following:

- 1. If deemed fit to provide regular and effective service and assigned to a post, their civil service ill-health pension ceases.

Appointment post ill-health retirement from Public Service

- 1. Where an individual has retired from a public service body his/her ill-health pension from that employment may be subject to review in accordance with the rules of ill-health retirement under that scheme.
- 2. If an applicant is successful, on appointment the applicant will be required to declare whether they are in receipt of a public service pension (ill-health or otherwise) and their public service pension may be subject to abatement.
- 3. The applicant will become a member of the Single Public Service Pension Scheme (SPSPS) upon appointment if they have had a break in pensionable public/civil service of more than 26 weeks.

Pension Accrual

A 40-year limit on total service that can be counted towards pension where a person has been a member of more than one pre-existing public service pension scheme (i.e. non-Single Scheme) as per the 2012 Act shall apply. This 40-year limit is provided for in the Public Service Pensions (Single Scheme and Other Provisions) Act 2012. This may have implications for any appointee who has acquired pension rights in a previous public service employment.

Additional Superannuation Contribution

This appointment is subject to the Additional Superannuation Contribution (ASC) in accordance with the Public Service Pay and Pensions Act 2017. Note: ASC deductions are in addition to any pension contributions (main scheme and spouses' and children's contributions) required under the rules of your pension scheme.

Shortlisting

A shortlisting process will involve an expert panel that will select candidates for interview who, based on an examination of the application form and assessed against the essential requirements and personal attributes required, appear to be the most suitable for the position.

Confidentiality

Subject to the provisions of the Freedom of Information Act, 2014 applications will be treated in strict confidence.

Security Clearance
